#### CALL TO ORDER

An Action on the Board of Director position, term commencing 2023 was presented. President Sheffer turned the meeting over to Vice President Sheperd as she currently holds the position with term commencing 2023. Sheperd stated two individuals were interviewed for the position. Present for the interview was himself, Secretary Carson and Otsego Local School Board President Brad Anderson and Board Member Jessica Mehl. Sheperd stated both candidates were highly qualified for the position and presented themselves very well at the interview. Discussions were conducted with the Otsego Board Members after the interview and their opinions were taken into consideration. The committee recommended Cindy Sheffer for the term commencing 2023. A Motion to nominate Cindy Sheffer for the Board Position commencing 2023 was made by Archambo; second by Gamby. The recommendation of Cindy Sheffer for the Board position commencing 2023 will be presented to the Otsego Local School Board for approval.

## **DIRECTOR UPDATE**

The Director updated the Board that an adult metal class will take place at Weston on October 22, 2022. All equipment and supplies will be provided by the instructors. The class is not full at this time.

Board member Sheperd asked about a "Pop It, Paint It" type of class being scheduled at the library. The Board was informed that such a class is scheduled to take place at the Grand Rapids Library.

The Director indicated that a new reading program will be implemented in January for birth through adult. It will be a challenge with rewards available.

The Director indicted to the Board that temporary appropriations will be discussed at the November meeting and board members should let her know if there is anything they would like to see added to the appropriations. The Director stated that she is looking into new lighting at both locations.

The Director updated the Board regarding ARPA federal funds available through Wood County.

She attended the hearing with the Wood County Commissioners and spoke on behalf of the library. The Director indicated that the Wood County Library system was denied the grant.

The Director updated the Board regarding the Dolly Parton Imagination Library. She stated 3,725 children in Wood County are receiving books through the program, including 197 Otsego School District children.
